USER VIEWS VS YOUR OWN

A common question support received from County Recorder Offices was about how user views differ from the county view and what limitations the community user may encounter.

Individual users(non-business users) have access to...

- **UNLIMITED** searches & index views
- Limit of **10 IMAGE VIEWS** per day

Business users have a limit of **120 IMAGE VIEWS** per day. Individuals and business users may complete a form to request a reasonable extension for more image views. County Recorder offices may direct business users to the image view extension form [HERE](#).

Recorders and staff have access to **UNLIMITED** everything. For more user-related questions, please contact our support team at support@clris.com.
